#### **Objectives**

Boyanika invites “Expression of Interest” from the Professional Designers for development of readymade garments both for gents and ladies using Odisha Handwovens. Boyanika will provide space for display of these garments in its established Show-rooms preferably at Bhubaneswar, Puri, Cuttack, Rourkela etc. on the following terms and conditions:

#### **Terms & Conditions**

1. He/She must have a professionally qualified from NIFT, NID or any recognized Govt. Fashion Institute.
2. He/She must have an experience of minimum 5 years in garment manufacturing.
3. He/She must have his/her own stitching unit.
4. The items brought by the designers will be checked thoroughly in Quality Control Cell and retail price will be fixed as per the coding system of Boyanika before it is displayed.
5. Preferences will be given to the Designer, who will purchase and use Boyanika's Fabrics in their developed garments.
6. The Designer is outside Service Provider hence, he/she has not any master and servant relationship with the Principal.
7. The Designer shall not sale the same Design Garment to any third party without prior consent of the Principal which he/she already sold to the Principal.
8. Minimum stock worth of Rs.5.00 lakhs of a Designer should be kept in his/her allotted place. The Principal has sole discretion to increase or decrease the quantity of the product.
9. The Designer is required to show case his/her products in the E-commerce website of Boyanika. He/she should ensure sufficient in flow of stock to the E-commerce site.
10. The Principal may at any point of time take a decision to purchase specific design dress materials. The payment of such purchase will be made within 15 days from the submission of Bill.
11. A Memorandum of Understanding will be signed between the Designer and Boyanika the Principal before starting the operation.
12. The Designer has right to withdraw from the MOU with one month notice to the principal with clearing all its dues.

14. Any dispute arises out of the execution/operation of MOU, it will be referred Director of Textile or his authorized sole arbitrator for adjudication as per the provisions of the Arbitration and Conciliation Act, 1996.

The Designer should have registered their firm with GST & Income Tax. They should submit their GST certificate & latest Income Tax Clearance Certificate and samples (photos) of their developed products with rate along with their expression of interests.

The Expression of Interest, complete in all respect should reach in sealed cover by courier/speed post/Registered post to Managing Director, Boyanika on or before 03.06.2022. In no case delivery by hand will be accepted. The authority shall not be responsible for any postal delay. The Expression of Interests will be opened on the next day i.e.04.06.2022 at 11.00 A.M at Head Office, Boyanika in presence of the Bidders or their authorized representatives.
