The Odisha State Handloom Weavers Cooperative Society Ltd., (boyanka) is inviting Expression of Interest for Painting Work of Head Office Building, Boyan Bhawan, Bhubaneswar. Sealed EOI in two bids "Technical Bid" & "Financial Bid" are invited from reputed firms/contractors having past experience and expertise to execute such type works for Painting etc. in accordance with the EOI documents as follows:

- 1 Name of the work : Painting Work of Head Office Building, Boyan Bhawan, Bhubaneswar.
- 2 Earnest money to be deposited : Rs.10,000.00 (Rupees Ten thousand) only in shape of DD drawn in favour of the Odisha State Handloom WCS Ltd in any scheduled/commercial bank payable at Bhubaneswar.
- 3 Cost of EOI document / Processing Fee : Rs.4,000.00 (Rupees Four thousand) only (Non-refundable)
- 4 Availability of tender in the website : www.boyanka.com from **Dt.05.03.2024** to 1.00 PM on **Dt.11.03.2024**

- 6 Date of opening of EOI : The Technical bids will be opened in presence of the parties or their authorized representatives at 1 PM on **Dt.12.03.2024** at Conference Hall of Boyanka, Boyan Bhawan, Bhubaneswar and the bidders are required to present a power point presentation regarding their 3D Design of the building along with alternative colour combination at the time of opening of the Technical Bid.
The Financial bids in respect of the parties qualified in Technical Bids will be opened at 1.30 PM on same day i.e. **Dt.12.03.2024** at Conference Hall of Boyanka, Boyan Bhawan, Bhubaneswar.
- 7 The interested parties should visit the work site at their own arrangement & ensure about the existing condition of the site, nature of the site, the means of access to the site, the accommodation they may required & in general shall themselves obtain all necessary information as to risks, contingencies & other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspect it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work, as necessary and unless otherwise specifically provided for in the contract documents.

- 8** The sealed offers containing Technical Bid (cover-I) and Financial Bid (cover-II) in separate sealed covers to be sealed in a single envelope in conformity with EOI and terms & conditions of the bid document should reach the office of the undersigned by scheduled date & time. The bidders are required to sign the each page of their submitted documents failing which offer shall be treated as canceled.
- 9 The Technical bid must be accompanied with the following documents**
 - I** The cost of EOI documents/Processing fee in shape of Demand Draft.
 - II** EMD in shape of Demand Draft.
 - III** Detailed 3D Design of the building in respect of the proposed Painting Work. (The bidders are required to present a power point presentation on their 3D Design of the building along with alternative colour combination).
 - IV** Self attested photocopy of GST/GSTIN registration certificate and return copies up to 31st January 2024.
 - V** Self attested photocopy of PAN and return certificate of income tax for financial year 2020-21, 2021-22 & 2022-23
 - VI** Self attested copy of the Work Order of similar work if any.
 - VII** Self attested photocopy of valid electrical license from Competent Authority or authorization from any registered electrical contractor having experience in execution of such type of works for execution of electrical work. In case of authorization from any registered electrical contractor, the self attested copy of the valid electrical license of contractor has to be submitted along with proper Memorandum of Undertaking.
 - VIII** Audited statement of accounts (Balance sheet & Profit Loss account) of the firm for the business showing average turnover not less than 50.00 Lakhs (Rupees Fifty lakhs) only for the last 3 financial years (2020-21, 2021-22 & 2022-23) and I.T. return Acknowledgements.
 - IX** ESI & EPF registration certificate along with latest return copies.
- 10** The work shall have to be executed within 10 days time from the date of issue of the work order. The parties having necessary expertise & competency to execute the work with their own arrangement by taking the materials and workers to the site according to the availability and to complete the work within the specified time without hampering the business activities/normal official work of the building should only participate in the EOI process.
- 11** The financial bid must be submitted as per the EOI schedule covering/mentioning all the required items of work in befitting manner submitted in Technical Bid. The price quoted should be exclusive of GST but inclusive of all other components like cost of materials, labour charges, transportation charges both for materials and labour, cost towards lifting the materials to the specified work site and any other charges if any. The Financial Bid must be submitted as per prescribed format of schedule of items & quantities, but submission of Financial Bid other than this prescribed format shall be out rightly rejected.
- 12** The Authority is not bound to accept the lowest offer and reserves the right to finalize the EOI according to the selected design and credibility.
- 13** If the office happens to be closed on the last date of receipt of bids as scheduled, the bids will be received on the next working day at the same time & venue.
