- VI Self attested copy of the Work Order of similar work if any.
- VII Audited statement of accounts (Balance sheet & Profit Loss account) of the firm for the business showing average turnover not less than 50.00 lakhs (Rupees fifty lakhs) Only for the last 3 financial years (2020-21, 2021-22 & 2022-23) and I.T. return Acknowledgements.
- The selected bidder shall have to supply the materials within 7 days time i.e. 9 by 18.03.2024. The parties having necessary expertise & competency to supply the materials within the specified time should only participate in the EOI process.

The price quoted should be exclusive of GST but inclusive of all other components like cost of materials, labour charges, transportation charges both for materials and labour, cost towards supply of the finished materials to the Boyan Bhawan at PJN Marg, Unit-III, Bhubaneswar. The Financial Bid must be submitted as per prescribed format of schedule of items & quantities, but submission of Financial Bid other than this prescribed format shall be out rightly rejected.
